1. Briefly Noted

Ladies and Gentlemen,

it appears to have become fashionable to consider difficult and critical decisions as "without alternative", which brings to my mind an old Latin proverb "Many roads lead to Rome!"

For over 15 years there have been clear indications that Chormium VI –compositions ought to be replaced in the surface pre-treatment process, and our association has been been working on alternative pre-treatment processes in close collaboration with the Aluminium Industry as well as Pre-treatment chemical suppliers ever since. For over 10 years now, GSB approved coaters and licenced Premium Coaters have been working with chromium free pre-treatement systems. The results achieved are comparable to those produced by chromating systems.

Pre-anodising is a further pre-treatment process we have been actively involved in, which has produced excellent test results in terms of corrosive protection prarticularly in maritime climatic conditions.

Since the introdcution of declaration free pigmenting, the GSB has taken on a pioneering role often against some resistance from within the industry, and nowaday even in Southern Europe the renunication of using pigments containing heavy metals has become a matter of course.

The introduction of sustainable and environmentally friendly systems and processes requires a huge amount of time and dedication – but are we not duty bound to explore such alternatives?

Revision and Extension of the Quality Regulations GSB AL 631 and GSB ST 663

Dr. Blecher and Mr. Beljaars introduced the revision and extension of the GSB Quality Regulations AL 631 and GSB ST 663, which had been distributed to all members prior to the meeting, to all delegates in some detail. The changes were sanctioned by a significant majority and are currently in the process of being integrated and published in the Quality Regulations.

• IQC - Industrial Quality Coating

Mr. Alfort and Mr. Mader elaborated on the meaning and structure of the planned Quality Association, which areas it will affect and what type of operations will be included:



Industrial Quality Coating International (IQC) is an autonomous quality association within the GSB International e.V.

The Members' Assembly voted with a large majority in favor of the introduction of IQC and charged the Board with the establishment of this quality association.

The IQC 654 Quality Regulations apply to the industrial coating with powder lacquer of piecework made from steel, galvanized steel as well as aluminium and its alloys. Coated piecework destined for architectural external use is excluded, which now provides a clear distinction to the previous regulations and adequately represents the extremely high quality standards of Aluminum and Steel Facades in line with GSB AL 631 and GSB ST 663. The inclusion of liquid lacquers is scheduled as a next step development.

The new Quality Regulations include tried and tested standards covering the pre-treatment and coating processes, internal as well as external control procedures which have been specifically adapted to the requirements of the industrial coating and equipment markets.

The new IQC International Quality Label represents an extension into other market areas and can be used by Members as an additional quality standard to the existing GSB Quality Labels.
