After 36 successful years of voluntary service to the GSB International, Hans-Jürgen Alfort resigned from his position as Chairman of the GSB Board and was appointed Honorary Chairman. The Board unanimously elected Mr. Willem Beljaars as the new Chairman of the GSB International, Düsseldorf.

Members' General Assembly

Board Report

Chairman of the Board, Hans-Jürgen Alfort reported to the internal Members' Assembly on two eventful years of business under the headline of:

-GSB International-Think Tank For Excellence in Surface Technology

Following the Head Office relocation from Schwäbisch Gmünd to Düsseldorf, processes were re-defined and the Quality Regulations were reviewed and restructured. Numerous events and participation in exhibitions all over Europe served to promote and further spread the message of high quality standards. Over the coming years, the GSB intends to build country specific resources to further strengthen its position within Europe.

Since its conception in 1976 the GSB has been and shall continue to be a pioneer in the quality assurance of coated Aluminium through innovation, discovery and realisation of future developments. In September 2017 the curtain will finally fall on chromating processes and the transition will no doubt pose a considerable challenge for coaters over the coming years. As a result of research and development projects started over 15 years ago on quality standards and the licensing of Chromium free surface pretreatment processes, GSB Members already have alternative systems at their disposal which have been proven to produce qualitatively comparable as well as commercially viable results. The GSB additionally supports its members during the transition period with a comprehensive range of specific training courses and documentation.

For over 30 years, the GSB International has proved itself as a reliable partner to architects, metal construction companies, material suppliers and coaters. Worldwide the GSB remains the first Quality Association for coated Steel and Aluminium piecework used in the building industry with its ongoing objective to protect the quality assured coating of architectural Aluminium and Steel and to further develop quality standards in line with the latest advances in technology.

Reports of the Technical Commissions

The Chairmen of the Technical Commissions Mr. Bernd Kassing, TC Aluminium,



and Mr. Willem Beljaars, TC Steel,



reported on the activities, research and development projects in their relevant sectors.

The following focus topics were discussed at the TC meetings:

- Assessment of coater tests
- Evaluation of temperature graphs
- Assessment of system tests
- Licensing of alternative pretreatment systems



- Test processes and records
- Review of the pre-anodising check list for routine testing
- Revision of GSB-Info / Data Sheets
- Maintaining the list of the most popular colour groups ("Trend Colours")

Alongside the further development of the Steel sector, the transition to Chromium free surface pretreatment systems by September 2017 has been a focal point. Compared to the advances made in the Aluminium sector, valuable experience is somewhat lacking in the galvanised Steel sector where more research and development work is required.

Working with both Technical Commissions, the QR GSB AL 631 and QR GSB ST 663 were revised and harmonised to facilitate the alignment of processes, where feasible. Only material specific requirements have remained exclusive to the relevant sectors.

4. Co-operation partners in Switzerland

A co-operation agreement was entered into with Mr Menet, Me-Network, Zürich (www.me-network.ch) to represent the GSB in Switzerland alongside his duties as Managing Director of the Swiss Aluminium Association (www.alu.ch) and his



work for other Swiss Associations.

5. From the work of the Technical Commission

New QR AL 631 and ST 663

The General Assembly approved all changes to the Quality Regulations. The final version will be circulated in due course and will be effective within a period of 4 weeks.

Q-Lab Test Sheets

According to information released by the FEM test sheets produced by the company Q-Lab are made from band pretreated Aluminium which limits their suitability for coating material tests.

Pretreatment of test sheets for material testing

From 2014 alternative pretreatments will be used for licensing purposes of coated Aluminium. Extension tests will continue to be carried out on chromated sheets.

Labelling Controls

Checks to ensure that the labels of the chemicals and coating materials ordered corresponds to the labeling of consignments must be covered as part of the internal control process.

6. Valspar takeover of Inver

The Valspar Corporation (NYSE:VAL) are a leading manufacturer and supplier of colours and lacquers and announced their agreement to take over Inver Holding S.r.l. (Inver Group) as one of the top suppliers of industrial coatings in Europe. The transaction is said to be completed by Q4/2013 and is subject to approval by the relevant authorities as well as standard terms and conditions. Financial arrangements were not publicised.

7. Changes in Ownership

All members are duty bound to advise the GSB Head Office of any changes in ownership.

8. GSB Training Courses 2013

The first training course took place at the beginning of June at Chemetall in Frankfurt focusing on surface pretreatment.

The course attracted 21 delegates and covered both practical and theory sessions, with the practical focus on following subjects:



- Using titration to control the pre-treatment process
- Using photometry to categorise conversion layers
- Gravimetrical evaluation of stain removal and conversion layer weight
- Using the scanning electron microscope in surface analysis





Individual chromium free pretreatment systems were covered as part of the theory session, which was supported by detailed discussions concerning the implications of adapting existing plants and processes with practical examples.
